- Executing the attached tournament registration form and payment of the deposit - \$500.00 – this will guarantee your Tournament date. Initial _____
- Receiving confirmation of the size of the tournament 14 days prior to the tournament. Initial _____
 - Be aware of the Minimum number of players required. Initial _____
- Receiving the list of players 7 days before the tournament, including foursomes, unless assistance is required in forming groups. Initial _____
- Finalizing the proximity markers required (closest to the pin, long drive, long putt, etc.) 7 days prior. Initial _____
- Finalizing the number of meals required 10 days prior. Initial _____
- Full payment is due no later than two weeks after the completion of the tournament, unless other arrangements are made with the Tournament Coordinator.

Deposit Terms: (PLEASE NOTE)

- 100% of the initial deposit will be forfeited if the tournament is cancelled within 14 days of the tournament date by the client. Initial _____

IMPORTANT INFORMATION FOR TOURNAMENT/GOLF OUTING CLIENTS

COURSE ALCOHOL RULES: (Mandated by the Alberta Liquor Control Board)

- **Personal alcohol is not permitted**, all beverages must be purchased from Apple Creek Golf Course. Outside alcohol will be confiscated and the Tournament may be asked to leave the property or stop their round short of 18 Holes. Some players ruin the event for others.

TOURNAMENT FORMATS:

- Full Course Shotgun Starts are available – Minimum number of players is 100.
 - If your event only has 80 or 90 or 95 players – you WILL be charged for 100 players. Initials _____
 - Starting time – either 9:30am or 10:00am
 - Meal portion of the event to take place shortly after golf is completed – Approx. 3:30pm
- Modified Shotgun Starts are available – Minimum number is 60 Players – Maximum number is 72.
 - If your event only has 45 or 50 or 55 players – you WILL be charged for 60 players. Initials _____
 - Starting time – either 9:30am or 10:00am
 - Meal portion of the event to take place shortly after golf is completed – Approx. 3:30pm
- Tee Time starts – all Tournaments less than 60 players
 - Starting times may vary based on course availability.
 - Meal portion of the event to be discussed based on availability of the kitchen
 - Plated food service will start after 3 or 4 groups have completed their round.
 - Buffet options are available and need to be discussed with our Food & Beverage Team – based on availability. Buffet Minimum is 30 people.

OTHER ITEMS

- Power Carts are supplied by Apple Creek. The Tournament Coordinator will be required to sign a damage waiver (Tournament Contract) prior to the start of the Tournament. In addition, the Tournament Client will be held responsible should damage occur and Apple Creek experiences difficulty in collecting for the amount of the damage incurred. Initials _____
- Tournaments are expected to continue irrespective of weather, unless the Golf Course Superintendent deems the course unplayable. Initials _____
- All Food & Beverages must be purchased at Apple Creek Golf Course. Unless prior arrangements have been made with the Tournament Coordinator and Food & Beverage Team. Initials _____
- Apple Creek Staff are required to enforce Responsible Beverage Service, which includes limiting the amount of alcohol consumption. Initials _____
- Tournament clients are responsible for their players who may require a ride home. Initials _____
- Apple Creek Golf Course will be pleased to assist in providing a prize table consisting of Merchandise and additional gift certificates. Be sure to contact us ahead of time so we can properly prepare your Merchandise packages. \$10.00 / player. Initials _____
- Group Lessons can be arranged prior to your Tournament start time. This feature will need to be discussed with our Head Professional 2 weeks prior to your Tournament. Initials _____
- 1st Tee Gifts with a logo design are available – Hats, Balls, etc. (8 weeks notice) Initials _____
- Hole in One – can be initiated through the course as a very affordable option. Tournament Client is responsible for providing the required spotters based on the amount purchased. Initials _____
- Pace of Play – 4 ½ hours. Tournaments will be asked to leave the course at 5 hours. Initials _____
- Dress Code – All players must adhere to Apple Creek's dress code. Initials _____

APPLE CREEK GOLF COURSE POLICIES

GOLF ETIQUETTE:

- Repair all ball marks and fill divots with Sand & Seed provided

DRESS CODE:

- No jeans, cut offs, tank tops, tee shirts, sweat pants or swimsuits. Golfers will be required to purchase the necessary clothing if under dressed. Golfers who look the part, play the part!
- Soft spikes only; Metal spikes are not allowed. If no golf shoes – Running shoes are required.
- A selection of golf shirts will be offered at a reduced price to ensure there is a collar.

POWER CARTS:

- Power Carts are supplied by the golf course.
- ***Players are responsible for any damages to Power Carts, and the Tournament Coordinator guarantees payment by signing the Tournament Contract.***

WEATHER:

- Apple Creek reserves the right to decide when play is suspended due to the weather.

FOOD & BEVERAGES:

- All alcoholic beverages must be purchased at Apple Creek Golf Course.
- Outside food and beverages are not permitted on the course without written permission (in the case of sponsorship).

SPEED OF PLAY:

- Recommended play time of 4 ½ hours is expected. Tournaments will be asked to leave the course at 5 hours – no exceptions.
- ***SLOW PLAY WILL RUIN YOUR DAY, MARSHALS WILL MONITOR PLAY AND ASK PLAYERS TO PICK UP THEIR PACE, AND IN SOME CASES MOVE TO THE NEXT HOLE IF THEY ARE WELL BEHIND AND HOLDING UP OTHER GROUPS.***
- This will keep the game going at a steady pace and ensure an enjoyable round for all golfers.

ENVIRONMENTALLY SENSITIVE AREAS RULES:

- Play all hazards as lateral hazards. 2 club length relief from point of entry, take a 1 stroke penalty. Use the drop zones where provided. Holes #13 & #15
- If your ball is outside an environmental area, however, the environmental area interferes with your stance or swing, take free relief at the nearest point, no closer to the hole.
- ***DO NOT ENTER*** environmentally protected areas around the property. The environmental areas are protected in accordance with governmental regulations. Players who enter these areas maybe asked to leave the property.
- The Driving Range is out of bounds.

Please see the Pro Shop to purchase Range Balls prior to teeing off if not included in the Tournament price.
